### **EXPERTS DEMAND NEW CABINET RETHINK UK'S SECURITY APPROACH**

Rethinking Security, a network of peace and security experts, today called on Boris Johnson's ministerial team to adopt a more humane, collaborative and sustainable approach to international peace and security.

In open letters to the Defence, International Development and Foreign Secretaries, the organisation highlighted 10 actions to end the UK's contribution to worldwide insecurity and violence. It called on the new ministers to rethink the government's Global Britain agenda by prioritising a sustainable, collaborative approach to worldwide stability.

The experts recommend a focus on prevention of insecurity by tackling climate breakdown, inequality and marginalisation and rebalancing military forces away from expeditionary capabilities and towards territorial and cyber defence, where the need is greatest.

The letters pressed on the new ministers the importance of public opinion, noting that over half of UK adults oppose the use of UK troops in other countries and almost two thirds consider the sale of arms to Saudi Arabia unacceptable.

#### **Rethinking Security Co-ordinator Celia McKeon said:**

"These appointments, against the backdrop of Brexit, are a unique opportunity to rethink the UK's relationship with a changing world.

"Previous Cabinets have seen military might as the only way to keep people safe. They were wrong.

"In fact, conflicts are problems to be solved, not fights to be won. The UK public knows this<sup>1</sup>, and supports a vision of security that works with people and communities.

"We hope that the newly appointed ministers will meet with us to discuss our priorities in the coming months."
